I am directed to say that the Governor of Assam is pleased to convey the sanction of an amount of Rs. 542.23 lakhs (Rupees five crores forty two lakhs twenty three thousand) only for development of ethnic designs in Handloom for value addition and setting up of Handloom Growth Centre for Skill Development as financial assistance under State Plan, SIRD subject to availability of fund under the appropriate head of account in the current years budget 2009-2010 subject to the the following conditions :-

- (3) The scheme to be implemented in conformity with the project proposal for setting up of Growth Centres and objectives of the scheme proposed.
