The above selected Ombudsman / Deputy Ombudsman are engaged for a tenure of 2 years expandable by 1 year based on performance appraisal or till the incumbent attains the age of 65 years, whichever is earlier. There shall be no re-appointment. The Ombudsman / Deputy Ombudsman should join within two months of issue of notification before the Deputy Commissioner in Plains Districts and Principal Secretary in Sixth Schedule Districts.

3. The Ombudsman / Deputy Ombudsman shall be allowed compensation of Rs. 500/- per sitting. All powers and duties of Ombudsman / Deputy Ombudsman, procedure for redressal of grievances, etc are provided in Government of India's Order No. J-11011/21/2008-NREGA dated 7<sup>th</sup> September, 2009.
